
Public Works

Next Phase of the Main Street Improvements Project began on September 15

The phase of the Main Street Improvements Project through Old Town has reached completion over a month

ahead of schedule! Crews have completed asphalt paving operations and concrete work along Main Street, from the City limits to the new 10th Street roundabout.

On Monday, September 15, 2025, crews began constructing the next phase of the Main Street Improvements Project. This phase includes reconstructing select concrete curb, gutter, and driveway entrances before removing and replacing the existing asphalt pavement along Main Street between the 10th Street Roundabout and SR89A/East Cottonwood Street. Work will occur Monday through Thursday, from 6:00 a.m. to 6:00 p.m. During asphalt pavement reconstruction, crews will leave one lane open to travel in each direction; however, delays and temporary closures will be necessary. Access to properties will be maintained except for short durations when work occurs directly in front of a driveway. Access will be coordinated individually as we



move throughout the project. Residents, businesses, and motorists can expect lane closures and extensive traffic control measures throughout the construction. Please follow the marked signage to get to your destination.

Mingus Avenue and Main Street Intersection Improvements

The City's signal contractor has completed the planned upgrades to the traffic signal at Main Street and Mingus Avenue. Protected/permissive left-turn phasing (left-turn arrows) was added to both Mingus Avenue legs of the intersection, and the installation of new ADA-compliant pedestrian push buttons. Updated signal timing was also installed to accommodate the phasing changes. Special thanks are due to the Police Department for their assistance with traffic control while the signal was dark.

Cottonwood Public Library Stormwater Project

Combs Construction started work on the third and final phase of the Cottonwood Library Stormwater Project on August 21, 2025. Work completed on the first two phases included installing a new sidewalk extension, a new

rain basin on the library's west side, water-efficient landscaping, and two new scuppers on the east side of the building. The City obtained a grant from the Water Infrastructure Finance Authority of Arizona (WIFA) to complete the remaining low-impact development upgrades to the library. The WIFA grant provided 80% of the funding to complete the project's third phase.

The project's primary objective is to collect stormwater runoff from the library site and building through the installation of low-impact development features. Project elements will filter pollutants contained in stormwater runoff and improve drainage around the library. Work on the project's third phase included installing three new rain basins, upgrading the existing drainage basin on the library's north side, installing a new rain barrel to collect water from the roof drains, and planting water-efficient landscaping. Work on the drainage basins is complete, and the contractor completed planting on Thursday, September 11, 2025.









Police Department

Alternative Sentencing Program - Partnership

This week, Chief Freudenthal and staff met with Cottonwood City Prosecutor Josh Butner and local defense attorney Mike Shaw to reaffirm partnerships and goals of the alternative sentencing program. The Cottonwood City Prosecutor's Alternative Sentencing Program provides favorable plea or deferral agreements to local chronic low-level offenders who are homeless and/or mentally ill if they agree to, and complete, a Spectrum-developed assessment and treatment plan and other significant conditions.

Eligibility Criteria for Entry into Program:

Note: These criteria are intended to be flexible. Some may, or may not, apply.

- Local roots
- Multiple misdemeanor offenses
- Suspected mental illness or personality disorder
- Eligible for AHCCCS, SMI, or other benefits
- History of homelessness
- Motivation to engage in treatment and a reasonable likelihood of program success
- No use of a dangerous weapon in the charged offense
- First and only time in the Alternative Sentencing Program

The City Prosecutor has discretion in offering any defendant entry into the Alternative Sentencing Program. The City Prosecutor will consult with any defense counsel and the court regarding the program.

Cottonwood Detectives Arrest Robbery Suspect with Assistance from Phoenix Police

On Thursday, August 21, 2025, at approximately 10:20 a.m., officers and detectives from the Cottonwood Police

Department responded to a report of a robbery at the First Convenience Bank inside Walmart in Cottonwood, Arizona. During the incident, the suspect presented a note to a bank teller demanding money. The suspect obtained a substantial amount of cash and fled the bank on foot. In the weeks that followed, Cottonwood detectives conducted an extensive investigation. A suspect was identified through diligent investigative work, community cooperation, and the use of advanced technology.

On September 16, 2025, in collaboration with the Phoenix Police Department, Cottonwood detectives arrested 19-year-old Johnathan Pirvulescu in Phoenix. Following the arrest,

detectives served a search warrant at Pirvulescu's Phoenix residence, where additional evidence related to the crime was recovered. Pirvulescu was booked into the Yavapai County Detention Facility on charges of Robbery and Theft, both felonies. He is being held on a \$25,000 bond.

This arrest reflects a coordinated, multi-agency effort and highlights the dedication, persistence, and teamwork of all officers and detectives involved in successfully resolving this case.

from 4:30 p.m. to 7:00 p.m. at Cottonwood Kids Park at 350 S. 12th Street. On Monday, September 15, 2025, the Planning and Zoning Commission concurrently approved Design Review DR-25-012 and a Conditional Use Permit CUP-25-004 to allow site development of a helicopter hangar project and to allow accessory living quarters in an I-2 (Heavy Industrial) zone.

CUP-25-005

On Monday, September 15, 2025, the Planning and Zoning Commission approved a Conditional Use Permit to allow a 5.5-foot-tall fence in the front-yard setback within the AR-43 Zone.

Ordinance 764

On Tuesday, September 16, 2025, the City Council adopted Ordinance Number 764, which approves Municipal Code 2.110: Historic Preservation Commission changes, reducing its size and revising its powers and duties. Ordinance Number 764 will be in effect on October 16, 2025.
